This will confirm that, as always, Leviton and its subsidiaries will continue to supply quality products that are backed not only by Leviton's own product warranty but also by product liability insurance.

Any Leviton product supplied to you must not: (a) be misbranded; (b) falsely designate their origin; (c) violate applicable patent, trademark, and copyright laws; (d) be adulterated, abused, or mutilated; or (e) falsely or deceptively advertised. Any such alteration voids the warranty and the product liability insurance coverage.

We believe Leviton products meet all applicable Federal, Provincial and Local Municipal Safety, Health related regulations when shipped to you provided the Leviton products used and/or installed only in accordance with applicable electrical codes and regulations.

Leviton's Wiring Devices are exempt from OSHA's Hazard Communication Standards as well as Canada's Hazardous Products Act and the Workplace Hazardous Materials Information System (WHMIS) and, in turn, negate the need for issuance or maintenance of Material Safety Data Sheets (MSDS). Leviton Products do not contain asbestos or PCBs.

Leviton uses various types of packaging components to package its products. The packaging components can be categorized into three main groups: Printed Paperboard, Corrugated Cartons and Plastics.

We believe the use and handling of all of our printed paperboard packaging require no special safety precautions. The paperboard used in the production of these components is comprised of 100% recycled fibers.


The inks and coatings used in the production of these components do not constitute any known hazard in their cured and processed state. The inks used vary from oil, water or soy based and are completely cured in the manufacturing process. The paperboard used in the production of these components is comprised of 100% recycled fibers.

The inks and coatings used for printing these components are water based and require no special handling in their cured and processed state. Kraft, mottled white linerboard and hardwood fiber are the basic materials used in the production of our cartons. The use and handling of these materials pose no health or safety risks. Post-consumer recycled content varies, but generally will be less than 20%.

The use and handling of all of our packaging components consisting of plastic materials require no special safety precautions. These packaging components are made from 100% virgin Low Density PET resins, 100% virgin Polypropylene or 100% virgin PVC and meet all FDA regulations for packaging of food and medical products. Although Leviton Manufacturing Co., Inc. supplies electrical devices only, these packaging components meet FDA regulations and are safe for handling. All of these materials are recyclable in the appropriate category of established recycling standards (PVC code #3, LDPET code #4).
