INSTALLATION INSTRUCTIONS:

- 1. Insert leads, conductors or smallest parts of system through legs of boot.
- 2. Slide boot over cable section to be sealed. Press multi-legged boots firmly into the crotch of leads, conductors, etc.
- 3. Shrink boot by applying heat using hot air blower WT1400 (heat gun), SIT1 (torch) or other heat source. Boots start to shrink at approximately 250-275°F.
- 4. Start from the center of the boot to avoid trapping air under boot, then shrink the legs starting from the center of boot working toward the end of the legs. Shrink main end first. As heat is applied, move the heat source back and forth as well as around the boot.
- 5. When the boot assumes the configuration of the cable and excess sealant appears at the ends, discontinue heating as the shrink process is complete.
